She mentioned that the McCoy family (Cord, Sarah, and Tulsa) want Atoka to be their home and want people to associate the McCoy Rodeo with Atoka. At the Ada Rodeo, two weekends prior, they had two VisitAtoka.com banners as well as a rider carrying a flag in the arena after the calf scramble while speaking about what Atoka has going on. This coming weekend, the Tulsa Time Invitational for women will be filmed and aired on RFD.tv which is taking place at the McCoy Ranch. Ms. Wallis went on to discuss the Discover Oklahoma had a clip about Reba's Place and had a clip of the Atoka Museum and Civil War Cemetery. Thursday, Cindy and Miranda Donihoo will be driving to Oklahoma City to attend the meeting regarding the Jefferson Highway. Saturday, Cindy will be going to Oklahoma City History Center and giving a presentation of the Gene Smith Story. Ms. Wallis stated that the scholars and graduates are able to select a presentation out of submissions received and they have commented in the past of how much they enjoy the Atoka stories. The museum has also changed its hours and will now be closed on Monday's but will be open on Saturday's for tourism.

Trustee Pogue asked why the account must be at AmeriState Bank and not FirstBank, at which she was answered that while the city also banks with FirstBank, the checking accounts are held at AmeriState for easy transferring when needed. The account will need at least two signers, but the account will only require one signature at a time.

A motion was made by Trustee Pogue and seconded by Trustee Turner to establish the Atoka Tax Increment Finance District checking account at AmeriState Bank and establish Brian Cathey and Diane McGee to be the signers on the account. Voting aye, Pogue, Turner, McGee. Abstaining, Chairman Cathey. Voting nay, none. Motion carried.
